My Dear Fellow Parishioners,

I am pleased to share with you our Annual Financial Report for 2023-2024. I am thankful we can come together as a parish to worship, evangelize, and serve each other and those in need. Thank you.

We are grateful for the time Deacon Henry Vinklarek served our parish. Sadly, he died this summer in Houston, and his wife, Alicia, sends her love and gratitude to all of you for your prayers and support. Meanwhile, our sacristans, lectors, extraordinary ministers of the Eucharist, and ushers have continued to ensure our liturgies are celebrated properly and with reverence. Please consider sharing your time and talent by getting involved in one of these ministries, as they are all in need of new members. The music ministry enhanced our prayer at Mass and through sacred concerts such as the Seven Last Words during Lent and Lessons & Carols during Advent. "Through him then let us continually offer up a sacrifice of praise to God" (Heb. 13:15).

The Religious Education Department enjoyed another wonderful year. Starting with 50 children attending Vacation Bible School, there were 45 students enrolled in Christian Formation: nine received their First Sacraments, four were Confirmed, and one was received into the Church at the Easter Vigil through RCIA. Our Regina Caeli Homeschool Co-op continues to provide academic support and activities to families from ours and surrounding parishes and the annual Saint Nicholas Celebration was great fun as always. Our Youth Group is well-attended, and our Adult Formation programs included the popular reading and discussion groups led by John Bugbee.

Our parish received two direct benefits from your contributions to the Annual Diocese Appeal (ADA): Parish Share receipts totaled \$ 13,380, and we were awarded a \$2,500 Diocesan Fuel and Hunger Grant. The Grant, as well as your financial support from the second collection process, enabled us to assist a growing number of guests. Our Soup Kitchen served over 4,500 individual meals and over 5,000 individuals from 2,000 households received groceries from our Food Pantry. We also forwarded \$18,000 in contributions to Uganda, \$10,000 to Haiti, \$2,000 to the Society of St. Vincent de Paul, and \$2,000 to IMPACT.

Our Finance and Pastoral Councils work together to ensure the financial needs of our ministries and parish operations are being met. I feel confident we can continue to accomplish that goal if our 226 registered and active families are able to contribute \$2,094 per year, or about \$40 per week. If you are already tithing \$40 or more per week, thank you. If you are not, but are able to, please know how much your support is needed.

I am humbled by the hard work and dedication undertaken by our parish staff and volunteers to serve you. May God bless them and all of you for your faithful support of our Parish.
